**AN ORDINANCE APPROVING HEALTH INSURANCE
PLANS FOR ELIGIBLE CITY OF FENTON EMPLOYEES
WITH ANTHEM BLUE CROSS BLUE SHIELD.**

WHEREAS, competitive bids were obtained for Health Insurance Plans for eligible City of Fenton employees; and

WHEREAS, at the April 7, 2022 Committee Meeting, the Personnel Committee discussed the recommendation and found that Anthem Blue Cross Blue Shield was the most responsive, lowest, and best bidder to provide Health Insurance Plans for the City of Fenton’s employees and a recommendation was made to accept Anthem Blue Cross Blue Shield MEWA Blue Access Choice Options 2500/0%/4500 Plan 4 – 6B13 and 1000/0%/2500 Plan 1 – 6B0U as the Health Insurance Plans for City of Fenton employees; and

WHEREAS, the Board of Aldermen desires to approve MEWA Blue Access Choice Options 2500/0%/4500 Plan 4 – 6B13 and 1000/0%/2500 Plan 1 – 6B0U provided by Anthem Blue Cross Blue Shield as the Health Insurance Plans for eligible City of Fenton employees.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF FENTON, MISSOURI, AS FOLLOWS:

Section 1. MEWA Blue Access Choice Options 2500/0%/4500 Plan 4 – 6B13 and 1000/0%/2500 Plan 1 – 6B0U provided by Anthem Blue Cross Blue Shield for Health Insurance for City of Fenton employees under the terms set forth in Exhibit 1 attached hereto and incorporated herein (the “Health Plans”) are hereby approved, with such policy effective on June 1, 2022 for eligible City of Fenton employees.

Section 2. The Mayor is hereby authorized to execute all documents required for the City to institute the approved Health Plans coverage and to carry out the intent and purpose of this ordinance.

Section 3. This ordinance shall be in full force and effect after the date of its passage and approval.
