MAYOR'S CORNER Dear Neighbors,

Our City is abuzz with all the great projects and developments going on! For starters, we just proclaimed Fenton a "Purple Heart City." *This designation is given by the Military Order of the Purple Heart as a thank you to veterans and a reminder to the community of the sacrifices service-*

men and women have made. A Purple Heart is awarded to any armed forces member wounded or killed in combat. Thank you to Commander Sydney "Syd" Staten for the presentation and plaque, and to all our veterans for your service to our great country!

Second, there was a proclamation made for several 5th grade girls who organized a "sock drive" for the homeless. These girls attend Uthoff Valley Elementary and set an aggressive goal of getting 1,000 socks donated. They more than doubled their goal with over 2,300 socks donated for their cause (Making a Difference). I applied these young women for their hard work, dedication and kindness!

In the Parks Department, we are working on some upgrades to RiverChase: new marquee sign, resurfacing of the indoor pool, hot tub and slide, parking lot resurfacing and adding an irrigation system in Fenton City Park. Valiant Park has received new fencing (previous fence was there since the 60's) and is in the process of getting a new playground to replace the old equipment. City Staff is also looking into eligible grants for an "All Abilities Playground," which would provide inclusive play opportunities for children with and without disabilities. Our farmers' market has changed its hours and will now be the "Fenton Community and Farmers' Market." We look forward to seeing you there! Interviews are ongoing for a new Parks Director, and PRN (part time) employee merit increases were approved. City Staff is also working on RFP's (request for proposals) for building improvements and energy efficiency measures that will result in substantial cost savings for the City.

Several more flood-prone structures were purchased and demolished near the river (Opps Lane), 417 Center Street is awaiting demolition, and more are in process with the help of FEMA grants as we speak. Gravois Road Phase 2 easement and right-of-way discussions are continuing. Woodway Circle and Woodway Court are approved for a contractor to start the mill and overlay. Larkin Williams Road is approved for a contractor to start the mill and overlay and also to extend the sidewalks on the west side of the road up to the Horan intersection. Horan Drive is in the design phase and right-of-way plans have been submitted to MoDOT for review. Horan Drive updates will also include adding sidewalks to the south side of the road. Allen Road design work has begun, and Public Works is continuing tree removal throughout the City, weather permitting.

The Board of Aldermen made a motion to "Allow City Staff to stay on top of all developments surrounding Better Together that will affect Fenton, provide information on all facts and options, to invest in resources while staying in compliance with the City's legal limitations, and to report to the Board and make recommendations as they see fit." We will keep you updated and informed as things progress. Lastly, we once again approved a Zero Cent Municipal Tax Rate for general revenue purposes for all real and personal property!
