- (1) PAY YOUR FINE BY MAIL FOR YOUR VIOLATION IF THE FINE AMOUNT APPEARS ON THE REVERSE SIDE OF THIS SHEET. MAKE CHECK/MONEY ORDER PAYABLE TO: CITY OF FENTON. MAIL TO: CITY OF FENTON MUNICIPAL COURT, 625 NEW SMIZER MILL RD, FENTON MO, 63026.**
- (2) YOU CAN PAY ONLINE AT COURTS.MO.GOV. YOU WILL NEED TO HAVE THE CORRECT AMOUNT OF YOUR FINE AND TICKET NUMBER AT THE TIME OF YOUR PAYMENT.**
- (3) DUE TO COVID, YOU MAY UTILIZE THE COURTS DROP BOX DURING NORMAL BUSINESS HOURS (8:00AM-4:00PM). OUTSIDE THE CITY HALL THERE IS A BOX LABELED 'COURTS'. ONCE YOU GET HERE, PLEASE CALL 636-343-1007 EXT: 0 SO WE CAN COME OUT AND RETRIEVE YOUR PAYMENT IMMEDIATELY. IF YOU PAY WITH CASH IT WILL NEED TO BE THE EXACT AMOUNT AS WE CAN NOT GIVE CHANGE SINCE WE ARE CLOSED TO THE PUBLIC.**
- (4) CONTACT THE COURT PRIOR TO THE COURT DATE LISTED ON THE TICKET IF YOU DO NOT WANT TO PLEAD GUILTY AND SET UP A HEARING WITH THE JUDGE VIA TELEPHONE AND/OR ZOOM.**
