**BILL NO. 23-43**

**AN ORDINANCE AUTHORIZING THE MAYOR TO EXECUTE AN AMENDMENT TO THE AGREEMENT WITH ARAMARK UNIFORM SERVICES, & CAREER APPAREL, INC. TO EXTEND THE TERM.**

**WHEREAS**, the City currently has a contract with Aramark Uniform Services & Career Apparel, Inc. (“Aramark”) to provide professional uniform lease and rental and shop towel rental and cleaning services; and

**WHEREAS**, the existing contract with Aramark is set to expire on August 23, 2023; and

**WHEREAS**, during the Committee Meeting on May 4, 2023, the Public Works/Forestry Committee discussed and recommended extending the agreement with Aramark for three (3) years at the existing rates; and

**WHEREAS**, during the May 25, 2023, Board of Aldermen Meeting, the Board agreed with the Committee’s recommendation and finds it in the best interest of the public to amend the agreement to extend the term for three (3) years.

**NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF FENTON, MISSOURI, AS FOLLOWS:**

**Section 1.** The Mayor is hereby authorized to execute a first amendment to the Agreement with Aramark Uniform Services & Career Apparel, Inc. in substantially the form of Exhibit 1, attached hereto and incorporated herein, to extend the term for three (3) years.

**Section 2.** This ordinance shall be in full force and effect after the date of its passage and approval.

**EXHIBIT 1**

FIRST AMENDMENT TO THE  
CONSULTANT/SERVICES CONTRACT

This First Amendment is made this \_\_\_\_ day of \_\_\_\_\_, 2023, between the City of Fenton (“City”) and Aramark Uniform Services & Career Apparel, Inc. (“Consultant”).

**WHEREAS**, the City and Aramark entered into a consultant/services contract in 2018 for Aramark to provide professional uniform lease and rental and shop towel rental and cleaning services (the “Contract”); and

**WHEREAS**, the Contract is set to expire on August 23, 2023; and

**WHEREAS**, both parties desire to amend the Contract to extend the term by three (3) years.

**NOW, THEREFORE**, in consideration of the mutual covenants and agreements herein contained, the parties do hereby agree as follows:

1. The Agreement is hereby amended by amending Section IV, Contract Term, to delete the second paragraph and inset in lieu thereof the following paragraph:

Commencing on August 24, 2023, the term of the Contract shall be extended for three (3) years to terminate on August 23, 2026.

2. The parties hereby reaffirm that all other provisions of the Contract not specifically amended herein shall remain in full force and effect and shall be deemed incorporated herein and binding on the parties.

3. The Contract together with this First Amendment represents the entire agreement among the parties and Consultant agrees that it has not relied on any representations or warranties of the City, oral or written, other than expressly identified in this First Amendment.
